ILOILO CITY – PSA, RSSO 6 in coordination with Philhealth Regional Office VI conducted information dissemination to employees on Civil Registration on February 6, 2019 (10AM – 12NN). This activity was in line with the celebration of Civil Registration Month (CRM) with the theme: Inclusive and Responsive CRVS working Smarter through innovation. Registration Officer IV Mary Grace D. Dorilag discussed regarding civil registration services, steps on how to get civil registry documents in security paper (SECPA) and Vital Statistics.



Registration Officer IV Mary Grace D. Dorilag discussed the procedures on how to request civil registry documents and its requirements during Symposium on Civil Registration.



Administrative Officer IV Danny S. Leonor discussed the legal basis on how to correct civil registry documents during Symposium on Civil Registration.

Meanwhile, Administrative Officer IV Danny S. Leonor discussed about RA 9048 (an act allowing correction of entries and change of first name in the birth certificate) and RA 9255 (an act allowing illegitimate children to use father's surname), court decrees and legal instruments (adoption, legitimation, etc) and other civil registration related laws.

PSA, RSSO 6 in coordination with Iloilo National High School conducted information dissemination to Grade 12 students on Civil Registration on February 20, 2019 (8AM-12NN) for two batches. Statistical Specialist - II Jean Lito N. Esapol discussed to the students the importance and uses of Vital Statistics. He also pointed out the trend in various statistics in vital events.
