## RSC VI Resolution No. 05 Series of 2021

## APPROVING AND ADOPTING THE CORE REGIONAL SUSTAINABLE DEVELOPMENT GOALS INDICATORS (CORE-SDGI) FOR MONITORING IN WESTERN VISAYAS

**WHEREAS**, the Philippines is committed to the 2030 Agenda of Sustainable Development which consists of 17 developmental goals, 169 targets and 232 indicators covering economic, social and environmental dimensions of development;

**WHEREAS**, the PSA Board approved and adopted the Initial List of Sustainable Development Goals Indicators for Monitoring in the Philippines through the PSA Board Resolution No. 09 Series of 2017, which contains 155 indicators, of which 102 are global indicators, 28 proxy indicators and 25 supplemental indicators;

**WHEREAS**, in 2019, the PSA Board approved the Initial List of Core Regional SDG Indicators (CoRe-SDGI) based on the Official List of SDG Indicators for Initial Monitoring and its corresponding metadata and for adoption of the Philippine Statistical System as stated in PSA Board Resolution No. 12, Series of 2019;

**WHEREAS**, as stipulated in RSC Resolution No. 4, Series of 2020, the RSC created the Technical Working Group for the SDG to address matters to SDG and CoRe-SDGIs;

**WHEREAS**, an inter-agency workshop on the CoRe-SDGIs was conducted on September 01, 2021 to review initial regional targets vis-à-vis CoRe-SDGIs targets and baseline;

**NOW, THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED,** to approve and adopt the list of CoRe-SDGI with regional targets attached as Annex A and endorse the same to Regional Development Council VI for information and reference of concerned stakeholders and implementers;

**BE IT RESOLVED FURTHER**, that copies of the resolution be furnished to all concerned agencies for the annual provision of the necessary data for the computation of CoRe-SDGIs;

**RESOLVED FINALLY**, that the CoRe-SDGIs will undergo periodic review and may be amended as deemed necessary vis-à-vis Global and Philippine SDG indicators updates and developments.
