

A. Western Visayas

1. Headline Inflation

Western Visayas' headline inflation increased further to 4.3 percent in May 2024, from 4.1 percent in April 2024. The regional average inflation rate from January to May 2024 is 3.2 percent. In May 2023, the inflation rate was higher at 7.1 percent. (Table A, Figure 1, and Table D)

1.1 Main Drivers to the Uptrend of the Headline Inflation

The acceleration in the Western Visayas inflation rate in May 2024 was mainly due to the slower decline in the index of Housing, Electricity, Gas and Other Fuels at -0.3 percent during the month from -2.2 percent in April 2024. The second top contributor to the uptrend is Transport with 3.8 percent inflation in May, from 3.1 percent in April 2024.

Additionally, higher inflation was also noted in the indices of Clothing and footwear at 3.1 percent and Restaurants and Accommodation Services at 5.5 percent in May 2024.

In contrast, lower inflation rates were noted in the following commodity groups during the month:

- a. Food and non-alcoholic beverages, 7.0 percent from 7.3 percent;
- b. Alcoholic beverages and tobacco, 3.7 percent from 4.8 percent;
- c. Furnishings, household equipment and routine household maintenance, 2.3 percent from 2.8 percent;
- d. Health, 2.6 percent from 2.9 percent;
- e. Recreation, sport and culture, 3.8 percent from 4.3 percent, and
- f. Personal care, and miscellaneous goods and services, 2.9 percent from 3.1 percent.

The indices of Information and Communication at 1.0 percent; Education Services at 7.8 percent, and Financial Services at -1.0 percent, recorded inflation rates similar with the previous month's annual growths. (Table B).

1.2 Main Contributors to the Headline Inflation

The top three commodity groups contributing to the Western Visayas headline inflation rate of 4.3 percent in May 2024 were the following:

- a. Food and non-alcoholic beverages with 69.0 percent share or 2.97 percentage points;
- b. Restaurants and accommodation services with 7.9 percent share or 0.34 percentage point, and
- c. Transport with 7.7 percent share or 0.33 percentage point.

2. Food Inflation

Food inflation in Western Visayas slowed down to 7.3 percent in May 2024 from 7.5 percent in April 2024. Food inflation in May 2023 was recorded at 8.8 percent. (Table C)

2.1 Main Drivers to the Uptrend of Food Inflation

The deceleration of food inflation in May 2024 was due to slower annual growth in the index of Meat and other parts of slaughtered land animals with 11.2 percent inflation rate in May 2024 from 12.5 percent in April 2024. This was followed by Cereals and cereal products food group with 15.7 percent inflation rate from 16.0 percent in April. Fruits and nuts food group also contributed to the downtrend with 3.6 percent inflation rate in May from 6.1 percent in April.

Lower inflation rates were also noted in the following food groups:

- a. Fish and other seafood, 0.2 percent from 0.4 percent;
- b. Milk, other dairy products and eggs, 2.1 percent from 3.0 percent, and
- c. Oils and fats, -1.6 percent from -1.2 percent.

In contrast, higher inflation rates were observed in the indices of the following food groups:

- a. Vegetables, tubers, plantains, cooking bananas and pulses, 0.1 percent from -1.3 percent;
- b. Sugar, confectionery and desserts, -3.3 percent from -3.6 percent, and
- c. Ready-made food and other food products n.e.c., 5.5 percent from 4.8 percent.

2.2 Main Contributors to the Food Inflation

Food had a share of 66.7 percent or 2.87 percentage points to Western Visayas headline inflation rate in May 2024 (Table B). The top three food groups with the highest contribution to food inflation of 7.3 percent during the month were the following (Table C):

- a. Cereals and cereal products with 74.4 percent share or 5.43 percentage points;
- b. Meat and other parts of slaughtered land animals with 19.8 percent share or 1.45 percentage points, and
- c. Fruits and nuts with 2.0 percent share or 0.15 percentage point.

3. Inflation Rate for the Bottom 30% Income Households

Inflation rate for the Bottom 30% Income Households in Western Visayas increased to 5.4 percent in May 2024 from 5.2 percent in April 2024. Inflation rate for Bottom 30% income households was higher in May 2023, at 8.3 percent. (Table E)

3.1 Main Drivers to Uptrend of Bottom 30% Income Households Inflation

The uptrend in inflation rate for Bottom 30% Income Households was primarily brought about by the slower decline in the index of Housing, water, electricity, gas and other fuels commodity group at -1.5 percent in May 2024 from -4.6 percent in April 2024. This was followed by Transport with faster annual growth of 1.6 percent inflation rate from 1.0 percent in the previous month. Clothing and footwear commodity group with higher inflation rate of 3.0 percent during the month from 2.8 percent in April also contributed to the uptrend. (Table F)

B. Provinces

Half of the six provinces in Western Visayas, that is Capiz, Guimaras, and Iloilo recorded acceleration in inflation rates in May 2024 from April 2024. Among these provinces, Guimaras had the highest monthly inflation rate of 7.0 percent. The remaining three provinces – Aklan, Antique, and Negros Occidental had lower inflation rates compared to April 2024, with Negros Occidental recording the lowest at 4.2%.

Both highly urbanized cities in the region recorded uptrend in their inflation rates during the month. Iloilo City's monthly inflation rate is at 1.3 percent from 0.8 percent in April 2024, and Bacolod City at 4.5 percent from 3.9 percent in the previous month. (Table G)
