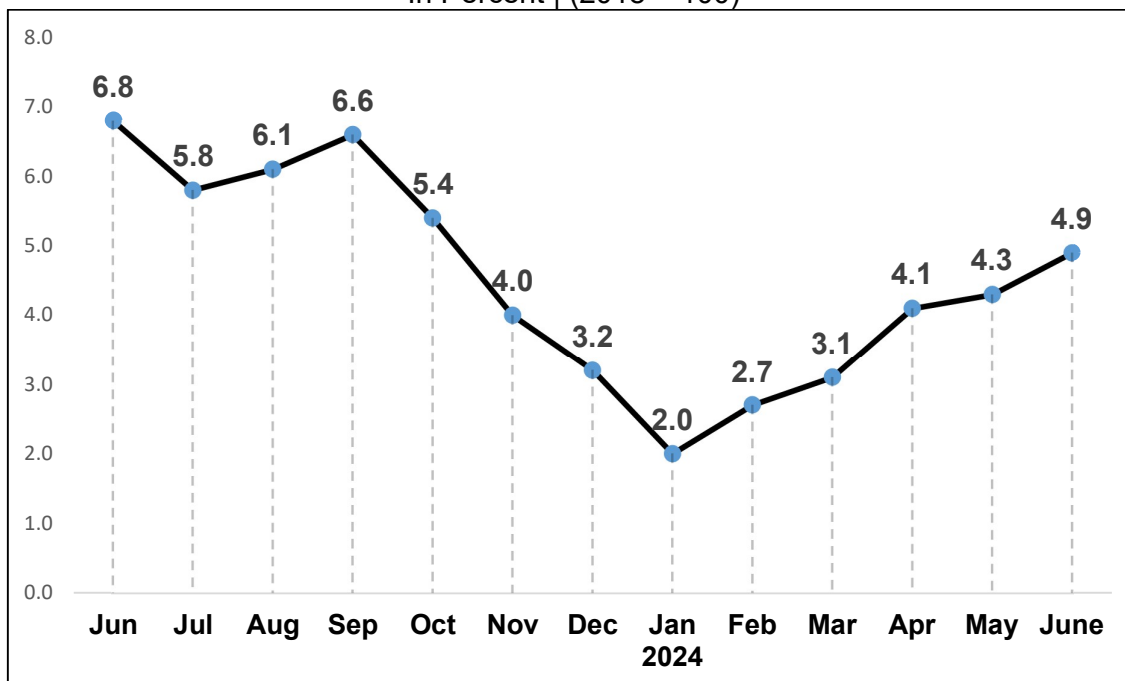

**A. Western Visayas****1. Headline Inflation**

Western Visayas' headline inflation increased further to 4.9 percent in June 2024, from 4.3 percent in May 2024. The regional average inflation rate from January to June 2024 is 3.5 percent. In June 2023, the inflation rate was higher at 6.8 percent. (Table A, Figure 1, and Table D)

**1.1 Main Drivers to the Uptrend of the Headline Inflation**

The acceleration in the Western Visayas inflation rate in June 2024 was mainly due to the higher annual growth in the index of Housing, water, electricity, gas and other fuels at 2.7 percent during the month from -0.3 percent in May 2024. The second top contributor to the uptrend is Clothing and footwear with 3.3 percent inflation in June, from 3.1 percent in May 2024.

Additionally, higher inflation was also noted in the indices of Health at 2.7 percent from 2.6 percent in the preceding month.

In contrast, lower inflation rates were noted in the following commodity groups during the month:

- Alcoholic beverages and tobacco, 3.3 percent from 3.7 percent;
- Transport, 3.2 percent from 3.8 percent, and
- Information and communication, 0.9 percent from 1.0 percent;

The indices of Food and non-alcoholic beverages at 7.0 percent; Furnishings, household equipment and routine household maintenance at 2.3 percent; Recreation, sport, and culture at 3.8 percent; Education services at 7.8 percent; Restaurants and accommodation services at 5.5 percent; Financial services at -1.0 percent, and Personal care, and miscellaneous goods and services at 2.9 percent, recorded inflation rates similar with the previous month's annual growths. ### *1.2 Main Contributors to the Headline Inflation*

The top three commodity groups contributing to the Western Visayas headline inflation rate of 4.9 percent in June 2024 were the following:

- a. Food and non-alcoholic beverages with 61.7 percent share or 3.03 percentage points;
- b. Housing, water, electricity, gas, and other fuels with 10.5 percent share or 0.51 percentage point, and
- c. Restaurants and accommodation services with 7.0 percent share or 0.35 percentage point.

## **2. Food Inflation**

Food inflation in Western Visayas rose to 7.4 percent in June 2024 from 7.3 percent in May 2024. Food inflation in June 2023 was recorded at 8.6 percent. (Table C)

### *2.1 Main Drivers to the Uptrend of Food Inflation*

The acceleration of food inflation in June 2024 was due to faster annual growth in the index of Meat and other parts of slaughtered land animals with 13.2 percent inflation rate in June 2024 from 11.2 percent in May 2024. This was followed by Fruits and nuts food group with 5.8 percent inflation rate from 3.6 percent in May. Milk, other dairy products and egg food groups also contributed to the uptrend with 2.7 percent inflation rate in June from 2.1 percent in May.

Higher inflation rates were also noted in the following food groups:

- a. Cereals and cereal products, 15.8 percent from 15.7 percent;
- b. Vegetables, tubers, plantains, cooking bananas and pulses, 0.6 percent from 0.1 percent, and
- c. Ready-made food and other food products n.e.c., 6.3 percent from 5.5 percent.

In contrast, lower inflation rates were observed in the indices of the following food groups:

- a. Fish and other seafood, -2.0 percent from 0.2 percent;
- b. Oils and fats, -2.0 percent from -1.6 percent, and
- c. Sugar, confectionery and desserts, -3.5 percent from -3.3 percent.

### *2.2 Main Contributors to the Food Inflation*

Food had a share of 60.1 percent or 2.95 percentage points to Western Visayas headline inflation rate in June 2024 (Table B). The top three food groups with the highest contribution to food inflation of 7.4 percent during the month were the following (Table C):

- a. Cereals and cereal products with 73.5 percent share or 5.44 percentage points;
- b. Meat and other parts of slaughtered land animals with 23.0 percent share or 1.70 percentage points, and
- c. Ready-made food and other food products n.e.c. with 3.2 percent share or 0.24 percentage point.

### 3. Inflation Rate for the Bottom 30% Income Households

Inflation rate for the Bottom 30% Income Households in Western Visayas increased to 5.9 percent in June 2024 from 5.4 percent in May 2024. Inflation rate for Bottom 30% income households was higher in June 2023, at 7.9 percent. (Table E)

#### 3.1 Main Drivers to Uptrend of Bottom 30% Income Households Inflation

The uptrend in inflation rate for Bottom 30% Income Households was primarily brought about by the higher annual growth in the index of Housing, water, electricity, gas and other fuels commodity group at 3.5 percent in June 2024 from -1.5 percent in May 2024. This was followed by Recreation, Sport and Culture with faster annual growth of 7.0 percent inflation rate from 6.7 percent in the previous month. Clothing and footwear commodity group with higher inflation rate of 3.1 percent during the month from 3.0 percent in May also contributed to the uptrend. (Table F)

## B. Provinces

All of the provinces in Western Visayas except Guimaras, that is Aklan, Antique, Capiz, Iloilo and Negros Occidental recorded acceleration in inflation rates in June 2024 from May 2024. Among these provinces, Aklan and Guimaras had the highest at similar 6.2 percent monthly inflation, while Capiz had the lowest at 4.7 percent inflation rate.

Both highly urbanized cities in the region recorded uptrend in their inflation rates during the month. Iloilo City's monthly inflation rate is at 2.2 percent from 1.3 percent in May 2024, and Bacolod City at 6.1 percent from 4.5 percent in the previous month. (Table G)
