

A. Western Visayas

1. Headline Inflation

Western Visayas' headline inflation increased to 3.9 percent in October 2024, from 3.4 percent in September 2024. The regional average inflation rate from January to October 2024 is 3.8 percent. In October 2023, the inflation rate was higher at 5.4 percent. (Table A, Figure 1, and Table D)

1.1 Main Drivers to the Uptrend of the Headline Inflation

The acceleration in the Western Visayas inflation rate in October 2024 was mainly due to the faster annual growth in the index of Food and Non-Alcoholic Beverages, which was noted at 4.3 percent during the month from 3.3 percent in September 2024. Transport was the second top contributor to the uptrend, which had -1.4 percent inflation in October from -2.1 percent in September 2024.

Additionally, higher inflation was noted in the index of Housing, water, electricity, gas and other fuels, at 5.8 percent from 5.6 percent; Clothing and Footwear at 4.2 percent from 3.8 percent, and Health at 3.2 percent from 3.1 percent.

In contrast, lower inflation rates were noted in the following commodity groups during the month:

- a. Alcoholic beverages and tobacco, 3.0 percent from 3.3 percent;
- b. furnishings, household equipment, and routine household maintenance, 2.3 percent from 2.5 percent;
- c. Information and communication, 0.8 percent from 0.9 percent;
- d. Recreation, sport and culture, 2.9 percent from 3.8 percent, and
- e. Restaurants and accommodation services, 5.8 percent from 6.1 percent

The indices of Education services recorded inflation rates of 8.1 percent; Financial Services at -1.0 percent, and Personal care, and miscellaneous goods and services at 2.8 percent which were similar to the previous month's annual growth (Table B).

1.2 Main Contributors to the Headline Inflation

The top three commodity groups contributing to the Western Visayas headline inflation rate of 3.9 percent in October 2024 were the following:

- a. Food and Non-Alcoholic Beverages with 46.8 percent share or 1.83 percentage points;
- b. Housing, Water, Electricity, Gas, and other fuels with 27.8 percent share or 1.09 percentage points, and
- c. Restaurants and Accommodation Services with 9.2 percent share or 0.36 percentage point

2. Food Inflation

Food inflation in Western Visayas grew to 4.6 percent in October 2024 from 3.4 percent in September 2024. (Table C)

2.1 Main Drivers of the Uptrend in Food Inflation

The uptrend in food inflation in October 2024 was due to higher annual growth in the index of Cereals and Cereal Products, with 13.8 percent inflation rate in October 2024 from 9.9 percent in September. This was followed by Milk, other dairy products and eggs with 4.4 percent inflation rate from 3.5 percent in September 2024. Vegetables, tubers, plantains, cooking bananas and pulses' food group also contributed to the uptrend with -8.2 percent inflation rate in October from -8.9 percent in September.

Higher inflation rates were also noted in Fish and other seafood at -4.2 percent from -4.5 percent; Oils and fats at -1.5 percent from -1.8 percent, and Confectionery, and Desserts, at -2.4 percent from -3.8 percent

In contrast, lower inflation rates were observed in the index of meat and other parts of slaughtered land animals, at 6.9 percent from 8.0 percent; Fruits and Nuts from 6.2 percent from 9.2 percent, and Ready-made food and other food products n.e.c. at 5.4 percent from 6.0 percent.

2.2 Main Contributors to the Food Inflation

Food had a share of 45.5 percent or 1.77 percentage points to Western Visayas' headline inflation rate in October 2024 (Table B). The top three food groups with the highest contribution to food inflation of 4.6 percent during the month were the following (Table C):

- a. Cereals and cereal products with 94.3 percent share or 4.34 percentage points;
- b. Meat and other parts of slaughtered land animals with 17.6 percent share or 0.81 percentage points, and
- c. Milk, other dairy products and eggs with 5.9 percent share or 0.27 percentage point.

3. Inflation Rate for the Bottom 30% Income Households

The inflation rate for the Bottom 30% Income Households in Western Visayas accelerated to 5.0 percent in October 2024 from 4.0 percent in September 2024. The inflation rate for the Bottom 30% income households was higher in October 2023, at 6.2 percent. (Table E)

3.1 Main Drivers to Uptrend of Bottom 30% Income Households Inflation

The uptrend in the inflation rate for the Bottom 30% Income Households was primarily brought about by the faster annual growth in the index of Food and Non-Alcoholic Beverages at 5.5 percent in October 2024 from 3.9 percent in September 2024. This was followed by Housing, water, electricity, gas and other fuels with higher annual growth of 9.4 percent inflation rate from 8.7 percent in the previous month. The Transport commodity group, with a higher inflation rate of -3.1 percent during the month from -4.1 percent in September, also contributed to the uptrend. (Table F)

B. Provinces

All provinces in Western Visayas recorded an acceleration in inflation rates from September to October 2024 except Guimaras which recorded a deceleration and Capiz with a monthly inflation rate similar to the previous month. Iloilo had the highest monthly inflation rate, at 5.0 percent, while Aklan had the lowest, at 3.1 percent.

In terms of the highly urbanized cities in the region, Iloilo City recorded an increase in their inflation rates during the month while Bacolod City decreased. Iloilo City's monthly inflation rate is at 4.1 percent from 2.8 percent in September 2024. On the other hand Bacolod City's monthly inflation rate is at 3.2 percent from 3.9 percent in the previous month. (Table G)
