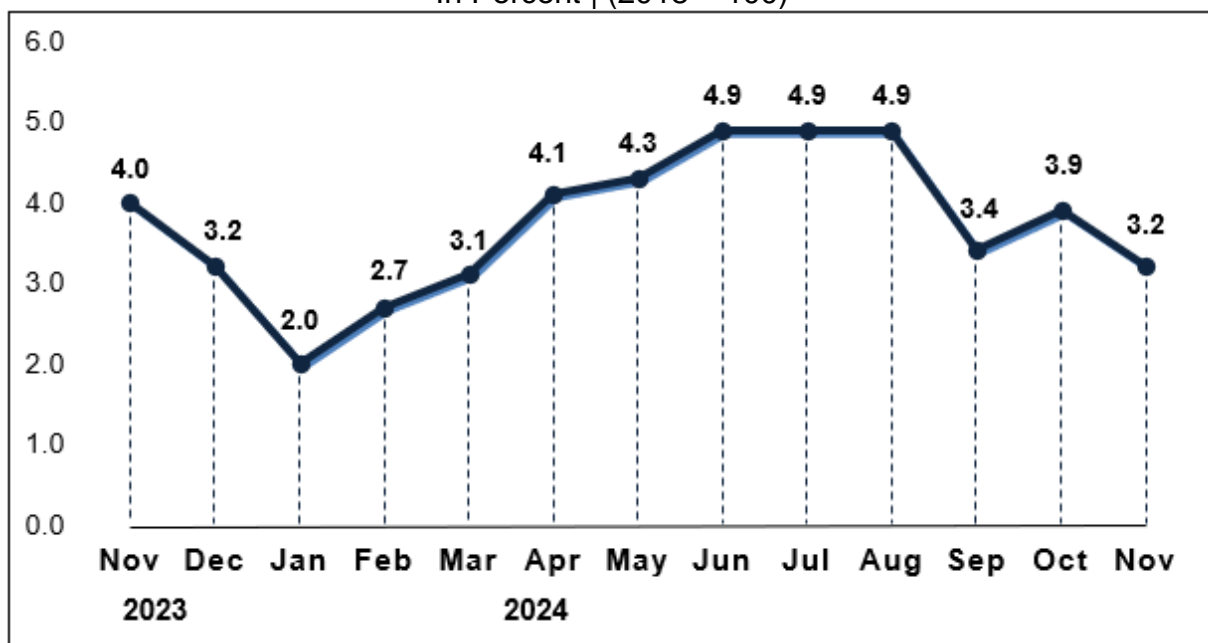

A. Western Visayas

1. Headline Inflation

Western Visayas' headline inflation decreased to 3.2 percent in November 2024, from 3.9 percent in October 2024. The regional average inflation rate from January to November 2024 is 3.7 percent. In November 2023, the inflation rate was higher at 4.0 percent. (Table A, Figure 1, and Table D)

1.1 Main Drivers to the Downtrend of the Headline Inflation

The deceleration in the Western Visayas inflation rate in November 2024 was mainly due to the slower annual growth in the index of Housing, water, electricity, gas, and other fuels which was noted at 3.3 percent during the month from 5.8 percent in October 2024. The index of Food and Non- Alcoholic Beverages was the second top contributor to the downtrend, which had 3.3 percent inflation in November from 4.3 percent in October 2024.

Additionally, lower inflation was noted in the indices of Health, at 2.9 percent from 3.2 percent; Information and Communication at 0.6 percent from 0.8 percent, and Recreation, Sport and Culture at 2.6 percent from 2.9 percent.

In contrast, higher inflation rates were noted in the following commodity groups during the month:

- Alcoholic beverages and tobacco, 3.1 percent from 3.0 percent;
- Clothing and Footwear , 4.4 percent from 4.2 percent;
- Furnishings, Household Equipment and Routine Household Maintenance, 3.4 percent from 2.3 percent;
- Transport, -0.1 percent from -1.4 percent, and
- Restaurants and accommodation services, 6.0 percent from 5.8 percent

The indices of Education services recorded inflation rates of 8.1 percent; Financial Services at -1.0 percent, and Personal care, and miscellaneous goods and services at 2.8 percent recorded inflation rates which were similar to the previous month's annual growth (Table B).

1.2 Main Contributors to the Headline Inflation

The top three commodity groups contributing to the Western Visayas headline inflation rate of 3.2 percent in November 2024 were the following:

- a. Food and Non-Alcoholic Beverages with 44.3 percent share or 1.42 percentage points;
- b. Housing, Water, Electricity, Gas, and other fuels with 19.5 percent share or 0.63 percentage points, and
- c. Restaurants and Accommodation Services with 11.7 percent share or 0.37 percentage point

2. Food Inflation

Food inflation in Western Visayas declined to 3.4 percent in November 2024 from 4.6 percent in October 2024. (Table C)

2.1 Main Drivers of the Downtrend in Food Inflation

The downtrend in food inflation in November 2024 was due to lower annual growth in the index of Cereals and Cereal Products, with 10.3 percent inflation rate in November 2024 from 13.8 percent in October. This was followed by Meat and other parts of slaughtered land animals with 2.4 percent inflation rate from 6.9 percent in October 2024. Fruits and nuts' food group also contributed to the downtrend with a 3.1 percent inflation rate in November from 6.2 percent in October.

Lower inflation rates were also noted in Fish and other seafood at -4.5 percent from -4.2 percent; Milk, other dairy products, and eggs at 4.1 percent from 4.4 percent; Oils and fats at -1.6 percent from -1.5 percent; Sugar Confectionery, and Desserts, at -2.6 percent from -2.4 percent, and Ready-made food and other food products n.e.c. at 5.1 percent from 5.4 percent.

In contrast, a higher inflation rate was observed in the index of Vegetables, tubers, plantains, cooking bananas, and pulses at -0.2 percent from -8.2 percent.

2.2 Main Contributors to the Food Inflation

Food had a share of 42.3 percent or 1.35 percentage points to Western Visayas' headline inflation rate in November 2024 (Table B). The top three food groups with the highest contribution to food inflation of 3.4 percent during the month were the following (Table C):

- a. Cereals and cereal products with 97.6 percent share or 3.32 percentage points.
- b. Meat and other parts of slaughtered land animals with 8.5 percent share or 0.29 percentage points, and
- c. Milk, other dairy products, and eggs with 7.6 percent share or 0.26 percentage points.

3. Inflation Rate for the Bottom 30% Income Households

The inflation rate for the Bottom 30% Income Households in Western Visayas decelerated to 3.7 percent in November 2024 from 5.0 percent in October 2024. The inflation rate for the Bottom 30% income households was similar in November 2023, at 5.0 percent. (Table E)

3.1 Main Drivers to Downtrend of Bottom 30% Income Households Inflation

The downtrend in the inflation rate for the Bottom 30% Income Households was primarily brought about by the slower annual growth in the index of Food and Non-Alcoholic Beverages at 4.1 percent in November 2024 from 5.5 percent in October 2024. This was followed by Housing, water, electricity, gas, and other fuels with lower annual growth of 4.6 percent inflation rate from 9.4 percent in the previous month. The Recreation, sport and culture commodity group, with a lower inflation rate of 3.3 percent during the month from 3.8 percent in October, also contributed to the downtrend. (Table F)

B. Provinces

All provinces in Western Visayas recorded a deceleration in inflation rates from October to November 2024. Aklan had the lowest monthly inflation rate, at 1.3 percent, while Iloilo had the highest, at 4.4 percent.

Both highly urbanized cities in the region recorded a downtrend in their inflation rates during the month. Iloilo City's monthly inflation rate is at 3.5 percent from 4.1 percent in October 2024, and Bacolod City at 2.7 percent from 3.2 percent in the previous month. (Table G)
