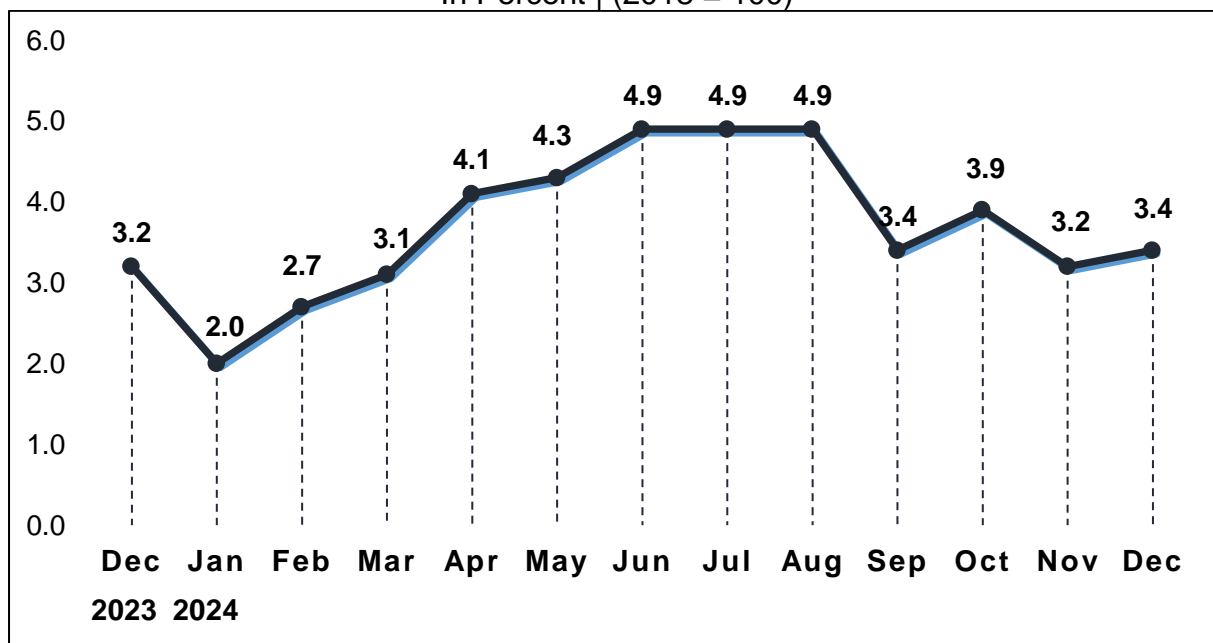

A. Western Visayas

1. Headline Inflation

Western Visayas' headline inflation accelerated to 3.4 percent in December 2024, from 3.2 percent in November 2024. The regional average inflation rate from January to December 2024 is 3.7 percent. In December 2023, the inflation rate was lower at 3.2 percent (Table A, Figure 1, and Table D).

1.1 Main Drivers to the Uptrend of the Headline Inflation

The uptrend in the Western Visayas inflation rate in December 2024 was mainly due to the faster annual growth in the index of Housing, water, electricity, gas, and other fuels which was noted at 4.8 percent during the month from 3.3 percent in November 2024. The index of Transportation was the second top contributor, with 1.8 percent inflation in December from -0.1 percent in November 2024. Furnishings, household equipment, and routine household maintenance was the third top contributor, at 4.1 percent inflation in December from 3.4 percent in November 2024.

Additionally, higher inflation was noted in the indices of Alcoholic Beverages and Tobacco, at 3.7 percent from 3.1 percent; Information and Communication at 0.7 percent from 0.6 percent, and Recreation, Sport and Culture at 2.7 percent from 2.6 percent.

In contrast, lower inflation rates were noted in the following commodity groups during the month:

- Food and Non-Alcoholic Beverages, 2.8 percent from 3.3 percent;
- Health, 2.4 percent from 2.9 percent; and
- Restaurants and Accommodation Services, 5.6 percent from 6.0 percent;

The indices of Clothing and Footwear with inflation rate of 4.4 percent; Education Services at 8.1 percent; Financial Services at -1.0 percent; and Personal care, and miscellaneous goods and services at 2.8 percent recorded inflation rates which were similar to the previous month's annual growth (Table B).

1.2 Main Contributors to the Headline Inflation

The top three commodity groups contributing to the Western Visayas headline inflation rate of 3.4 percent in December 2024 were the following (Table B):

- a. Food and non-alcoholic beverages, with 35.0 percent share or 1.19 percentage points;
- b. Housing, water, electricity, gas and other fuels with 26.5 percent share or 0.90 percentage point; and
- c. Restaurants and accommodation services with 10.2 percent share or 0.35 percentage point.

2. Food Inflation

Food inflation in Western Visayas declined to 2.8 percent in December 2024 from 3.4 percent in November 2024. Food inflation in December 2023 was higher at 7.3 percent (Table C).

2.1 Main Drivers of the Downtrend in Food Inflation

The downtrend in food inflation in December 2024 was due to lower annual growth in the index of Cereals and Cereal Products, with 7.0 percent inflation rate in December 2024 from 10.3 percent in November. Lower inflation rates were also noted in Ready-made food and other food products n.e.c at 4.1 percent from 5.1 percent.

In contrast, higher inflation rates were observed in the index of Meat and other parts of slaughtered land animals at 2.8 percent from 2.4 percent; Fish and other seafood at -2.9 percent from -4.5 percent; Milk, other dairy products and eggs at 4.2 percent from 4.1 percent; Oils and fats at -1.3 percent from -1.6 percent; Fruits and nuts at 3.5 percent from 3.1 percent; Vegetables, tubers, plantains, cooking bananas, and pulses at 0.8 percent from -0.2 percent; and Sugar, confectionery and desserts at -1.9 percent from -2.6 percent.

2.2 Main Contributors to the Food Inflation

Food had a share of 32.8 percent or 1.12 percentage points to Western Visayas' headline inflation rate in December 2024 (Table B). The top three food groups with the highest contribution to food inflation of 2.8 percent during the month were the following (Table C):

- a. Cereals and cereal products with 83.6 percent share or 2.34 percentage points.
- b. Meat and other parts of slaughtered land animals with 12.5 percent share or 0.35 percentage points, and
- c. Milk, other dairy products, and eggs with 9.8 percent share or 0.28 percentage points.

3. Inflation Rate for the Bottom 30% Income Households

The inflation rate for the Bottom 30% Income Households in Western Visayas is 3.7 percent in December 2024, which is similar to the previous month. The inflation rate for the Bottom 30% income households was higher in December 2023, at 4.1 percent (Table E).

3.1 Major Contributors to Constant Bottom 30% Income Households Inflation

The top three commodity groups contributing to the Western Visayas Bottom 30% Income Households inflation rate of 3.7 percent in December 2024 were the following (Table F):

- Food and Non-alcoholic beverages with 50.0 percent share or 1.85 percentage points;
- Housing, Water, Electricity, Gas, and other Fuels with 26.7 percent share or 0.99 percentage point; and
- Restaurants and Accommodation Services with 9.0 percent share or 0.33 percentage point

B. Provinces

The provinces of Aklan, Guimaras, and Negros Occidental recorded acceleration in inflation rates from November to December 2024, while the provinces of Antique, Capiz, and Iloilo inflation rates have slowed down.

For the highly urbanized cities, Iloilo City recorded uptrend in inflation rate during the month, at 5.4 percent from 3.5 percent in November 2024. On the other hand, Bacolod City's inflation rate decelerated to 2.4 percent from 2.7 percent in the previous month (Table G).
