


Figure 1. Headline Inflation Rates for All Items, Western Visayas:

A. Western Visayas

1. Headline Inflation

Western Visayas' headline inflation accelerated to 3.6 percent in January 2025, from 3.4 percent in December 2024. This is the highest inflation rate since October 2024 when the monthly inflation rate of 3.9 was recorded. In January 2024, the inflation rate was lower at 2.0 percent. (Table A, Figure 1, and Table D)

1.1 Main Drives to the Uptrend of the Headline Inflation

The uptrend in the Western Visayas inflation rate in January 2025 was mainly due to the faster annual growth in the index of Food and Non-Alcoholic Beverages which was noted at 3.4 percent during the month from 2.8 in December 2024. The index of Transportation was the second top contributor, with 2.2 percent inflation in January 2025 from 1.8 percent in December 2024. Restaurants and Accommodation Services was the third top contributor, at 6.0 percent inflation from 5.6 percent in December 2024.

Additionally, higher inflation was noted in the following commodity groups during the month:

- a. Alcoholic Beverages and Tobacco, 4.1 percent from 3.7 percent;
- b. Furnishings, Household Equipment, and Routine Household Maintenance, 4.3 percent from 4.1 percent;
- c. Recreation, Sport, and Culture, 3.1 percent from 2.7 percent;
- d. Financial Services, 0.0 percent from -1.0 percent; and
- e. Personal Care, and Miscellaneous Goods and Services, 2.9 percent from 2.8 percent.

In contrast, lower inflation rates were noted in the indices of Housing, Water, Electricity, Gas and Other Fuels at 3.6 percent from 4.8 percent and Information and Communication at 0.6 percent from 0.7 percent in December 2024.

The indices of Clothing and Footwear with inflation rate of 4.4 percent; Health at 2.4 percent; and Education Services at 8.1 percent recorded inflation rates which were similar to the previous month's annual growth. (Table B)

1.2 Major Contributors to the Headline Inflation

The top three commodity groups contributing to the Western Visayas headline inflation rate of 3.6 percent in January 2025 were the following (Table B):

- a. Food and non-alcoholic beverages, with 41.1 percent share or 1.48 percentage points;
- b. Housing, water, electricity, gas and other fuels with 19.2 percent share or 0.69 percentage point; and
- c. Restaurants and accommodation services with 10.5 percent share or 0.38 percentage point.

2. Food Inflation

Food inflation in Western Visayas increased to 3.4 percent in January 2025 from 2.8 percent in December 2024. Food inflation in January 2024 was higher at 4.3 percent. (Table C)

2.1 Main Drivers of the Uptrend in Food Inflation

The acceleration in food inflation in January 2025 was due to higher annual growth in the index of Fish and other seafood, with 0.9 percent inflation rate in January 2025 from -2.9 percent in December 2024. This was followed by the sub group of Vegetables, tubers, plantains, cooking bananas and pulses with faster annual increase of 6.7 percent during the month from 0.8 percent in the previous month. Meat and other parts of slaughtered land animals sub group also contributed to the uptrend with 5.2 percent inflation rate in January 2025 from 2.8 percent inflation rate in December 2024.

Faster annual growth was also noted in the indices of the following food groups:

- a. Sugar, confectionery and desserts, -1.5 percent from -1.9 percent;
- b. Milk, other dairy products and eggs, 4.3 percent from 4.2 percent;
- c. Ready-made food and other food products n.e.c., 4.2 percent from 4.1 percent; and
- d. Oils and fats, -1.1 percent from -1.3 percent.

In contrast, lower inflation rates were observed in the index of Cereals and cereal products at 3.3 percent from 7.0 percent and Fruits and nuts at 3.3 percent from 3.5 percent.

2.2 Main Contributors to the Food Inflation

Food had a share of 38.3 percent or 1.38 percentage points to Western Visayas' headline inflation rate in January 2025 (Table B). The top three food groups with the highest contribution to food inflation of 3.4 percent during the month were the following (Table C):

- a. Cereals and cereal products with 38.3 percent share or 1.30 percentage points;
- b. Meat and other parts of slaughtered land animals with 22.6 percent share or 0.77 percentage points; and
- c. Vegetables, tubers, plantains, cooking bananas and pulses with 16.6 percent share or 0.56 percentage points.

3. Inflation Rate for the Bottom 30% Income Households

January 2025 inflation rate for the Bottom 30% Income Households in Western Visayas decelerated to 3.4 percent from 3.7 percent inflation rate in December 2024. Inflation rate for Bottom 30% income households was lower in January 2024 at 2.6 percent inflation rate. (Table E)

3.1 Main Drivers to Downtrend of Bottom 30% Income Households Inflation

The downtrend in inflation rate for Bottom 30% Income Households was mainly brought about by the slower annual growth in the index of Housing, Water, Electricity, Gas and Other Fuels with 5.1 percent inflation rate during the month, from 7.1 percent inflation in December 2024. It was followed by Food and Non-Alcoholic Beverages, with inflation rate of 3.2 percent in January 2025, from 3.3 percent in the previous month. (Table F)
